Dealers arriving prior to 5 PM must remain at their tables until security is set at approximately 5 PM.

Application is hereby made for the period of the above show and convention. The base fee of \$275.00 will include the use of one 8-foot table, one backup table and a maximum of three (3) dealer badges. Corner tables include two 8-foot tables and one backup table. See SCNA Bourse Fees table on the reverse of this application. **THERE IS A \$100.00 PER TABLE MINIMUM NON-REFUNDABLE DEPOSIT** – which must accompany this bourse application otherwise the bourse application will not be accepted. **BALANCE MUST BE PAID BY AUGUST 1, 2025. THERE WILL BE NO REFUND OF ANY ADDITIONAL PAYMENTS FOR THE CANCELANATION OF A TABLE AFTER OCTOBER 1, 2025.** Any dealer not arriving by the first day of the show and who has not notified the Bourse Chairman will forfeit his table and all payments. Tables may not be transferred, sold, or shared without the consent of the Bourse Chairman. Every dealer and their employees must be an SCNA member. An application for membership is provided with this bourse application package and may be reproduced as necessary. Each dealer must have a separate bourse application on file, even when sharing tables. Dealers may store their merchandise Saturday night for an additional fee of \$50. All merchandise must be packed and moved to the designated storage area on Saturday and removed by 9 AM Sunday.

If you or your employees are not already SCNA members, or have not paid your annual dues, please add the annual membership fee of \$10 (paperless) or \$20 (Periodic SCNA Scanner Journals mailed) for each person to your check along with applications for membership for new members. **Badges will not be issued until all membership dues and bourse fees are paid in full.**
